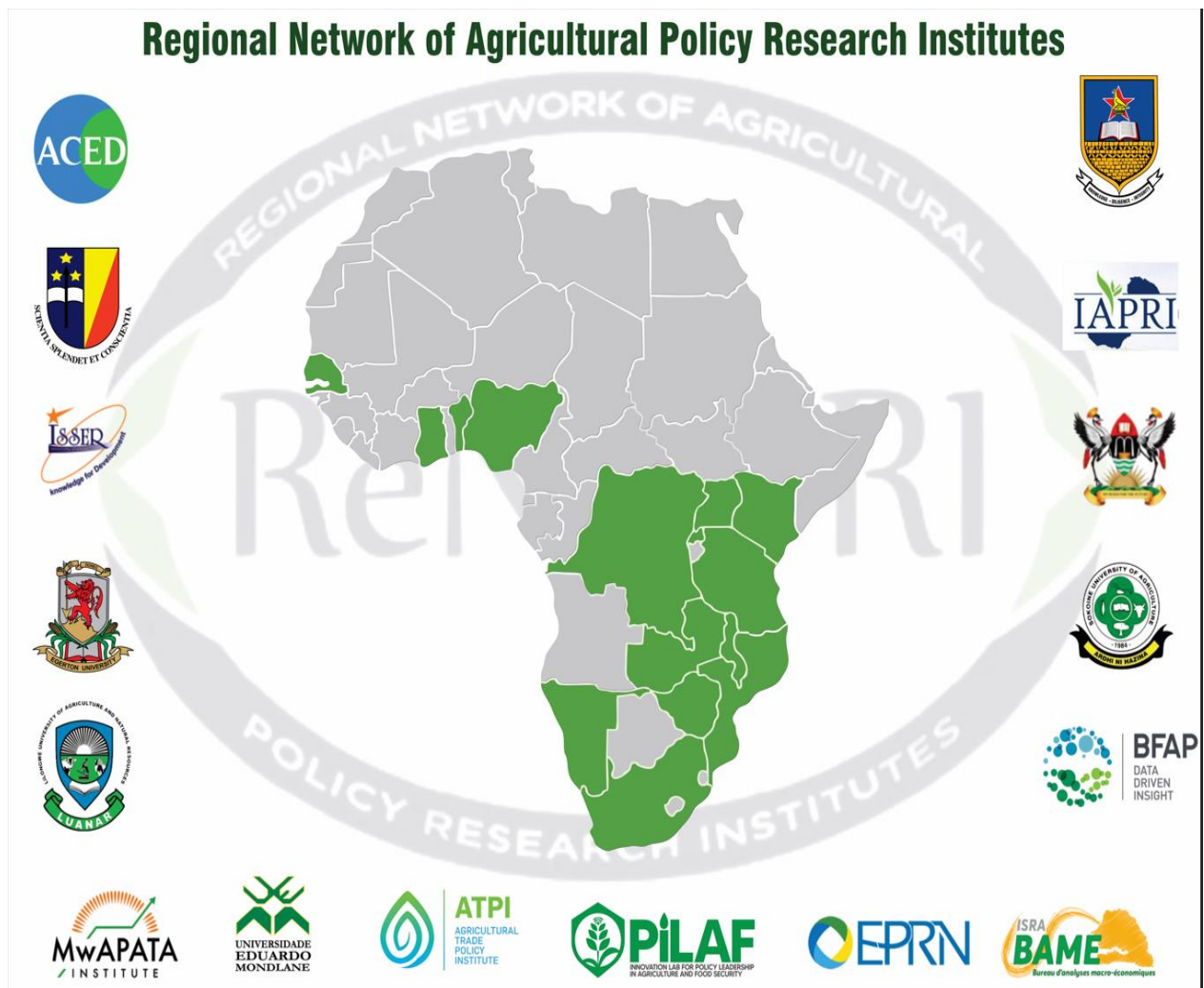

## CONCEPT NOTE

### INTRODUCTION

Drawing upon the wise words of Aldo Leopold who says, "*Land is not merely soil, it is a fountain of energy flowing through a circuit of soils, plants and animals*", it is possible to deduce that there is a strong link between land, and for that matter soil on one hand, and crops, livestock, and forestry on the other. It is no wonder that the Heads of State and Governments of the African Union, will soon pronounce themselves on a 10-year Action Plan for fertilizer and soil health on the continent. This plan will serve as a road map focused on high-impact solutions over a proposed 10-year horizon towards accelerating access to high quality fertilizers and sustainable soil management practices and investments (by of hundreds of millions of farmers) that are required to: reduce the yield gaps in Africa by enhancing soil productivity; halting soil degradation; restoring degraded soils; and mitigating and adapting to climate change.

ReNAPRI, has continued to play a critical role in supporting the African Union Commission in its efforts to organise the upcoming African Union Fertilizer and Soil Health Summit.

On another note, we are told that, "*Climate Change isn't something in the future... [That]... This narrative is fundamentally flawed*". Aneesa Khan further emphasizes that millions of people are already impacted as a result, while many are also displaced. It is therefore imperative for national governments around the world to address the issue of climate change and its effects on humanity and the planet, sooner rather than later. Within this context, ReNAPRI has partnered with AKADEMIYA2063, and Michigan State University to implement the Comprehensive Africa Climate Change Initiative (CACCI) to develop a proof of concept focused on supporting the implementation of nationally determined contributions and national adaptation plans by African countries. CACCI will then be scaled out to other countries, eventually. It is also essential to note that this initiative is also being implemented in other regions of the world (i.e., South-East Asia and Latin America & Caribbean)

Finally, Charles R. Swindoll says that "*We are all faced with a series of great opportunities [that] are brilliantly disguised as impossible situations*". One would say the same for value chain development in Africa - a great opportunity that currently seems impossible to actualize. But thanks to a project that is being implemented by ReNAPRI, with a focus on policy prioritisation through deep dive value chain analyses, key value chains will be examined vigorously for existing challenges, gaps, and potential triumphs!

### CONFERENCE THEME

The theme for this year's conference perceives of the continent as being, "**In Motion, fortifying Africa's food system through increased productivity, climate resilience and adaptation**". Africa is in motion towards strengthening its food systems and attaining agricultural transformation, despite several shocks and disasters that have faced the continent over the last few years. These setbacks include among others the fall armyworm and red locusts, the COVID 19 pandemic and climate change, and the effects of the Russia- Ukrainian War of food fuel and fertilizer prices and availability. The theme also focuses on the relevance

of value chains, fertilizer and soil health, and the need for member states of the African Union to effectively implement their Nationally Determined Contributions (NDCs) and National Adaptation Plans (NAPs), and report on progress made in the context of the Paris Agreement.

## CONFERENCE OBJECTIVES

ReNAPRI firmly believes that its role as a think tank is crucial in supporting socio-economic development in Africa. This conference is designed to create a platform for dissemination of research findings, strategic dialogue, evidence-based guidance, and stakeholder validation. The key objectives of the 10th Annual ReNAPRI Stakeholders' Conference are as follows:

1. Sparke policy conversations around key thematic areas that the network has explored in recent times (fertilizer and soil health; value chain analysis for policy prioritisation; climate change; effects of shocks on commodities (food, fuels and fertilizer availability and prices)
2. Receive feedback/validation from stakeholders, including policy makers, vis a vis the various topics that will be presented during the conference
3. Discuss and appreciate the relevance of local think tanks and the kind of support required to sustain them, as we celebrate the 10 editions of the ReNAPRI Annual Stakeholder Conferences.

The event will take place on 14-16 November 2023 at the Elephant Hills Resort, Victoria Falls in Zimbabwe.
